In the event it becomes necessary to use an attorney and/or collection agency in an effort to collect an outstanding balance from the Client, a fee of 30 % of the original invoice and any applicable attorney fees (up to a maximum of \$ 5,000) and/or any costs incurred in the collection process, will be assessed in addition to any accrued interest.

This Agreement is subject to the laws in force in the Province of Quebec. The Parties agree to elect domicile in the judicial district of Montreal, (Quebec) and select it as the appropriate district for the hearing of any claim arising from the interpretation, application, performance, validity and effect of this Agreement.

Customer agrees to pay cost of collection and reasonable attorney fees incurred by Quicksilver Express Inc. in the collection of past due accounts.
